



Terms and Conditions of Use for the electronic editions of journals

Franz Steiner Verlag

Preamble

The following Terms and Conditions of Use govern the rights and limitations of online access to those volumes and issues of the journals of Franz Steiner Verlag for which the Subscriber maintains a current paid subscription to the print version including online access.

The following Terms and Conditions of Use shall become effective at the moment of the activation of the licensed electronic contents (in the following “Licensed Materials”).

1.1 Licensed Electronic Contents, Authorized Users

Franz Steiner Verlag grants to the Authorized User the basic, non-exclusive, non-transferable, and non-sublicensable right as per the following terms and conditions to access and use the Licensed Materials over the period of the subscription. Access and use shall be via a stand-alone or virtual network within the internet that can be accessed solely by Authorized Users approved by the Subscriber whose identity is authenticated at the time of log-in and monitored periodically thereafter consistent with current best practice (Secure Network).

The License applies to the Subscription Period as per the following definition: The Subscription Period is the period nominally covered by the volumes and issues of the Licensed Materials independent of the actual date of their publication.

Access rights to the online archive of the published journals are expressly limited to the Subscription Period.

1.2 Authorized Site

This right of use generally applies for one localized site (physical location) that is under single administration. For organizations with locations in more than one city, each city is considered to be a separate site. For organizations that have multiple locations within the same city that are administered separately, only one location is considered to be involved.

For subscriptions that cover several sites (“multi-sites“), two additional licenses shall be issued after deliberation of the individual circumstances. If this applies to you, please request information from Franz Steiner Verlag at service@steiner-verlag.de

1.3 Authorized Users

Institutional subscribers shall be entitled to grant their Authorized Users access to the publications and permit their use. Access and use must take place via a stand-alone network or a virtual network within the internet that enables access solely to Authorized Users, who in turn are controlled and monitored by the institution (Secure Network). Authorized Users are:

- the current members of the teaching faculty of the Subscriber’s institution,
- library staff and other staff of the Subscriber’s institution,
- individual persons currently studying at the Subscriber’s institution,
- members of the public (walk-in users) visiting the library.

Visitors to the library/institution may be granted access to the licensed publications solely within the physical premises of the Subscriber’s institution at the Subscriber’s computer terminals at the authorized site.

All other Authorized Users shall be entitled to access the licensed publications both at the computer terminals within the library premises/institution or by remote access via the Subscriber’s secure network, if such a network is installed.

1.4 Access authorization

Access authorization is granted exclusively for the IP addresses of the authorized site or user names/passwords registered with Ingenta/Franz Steiner Verlag.

In the case of institutional access operations, there are no restrictions regarding the number of users accessing the system simultaneously, while for personal access operations solely the Subscriber is authorized.

2.1 Permitted uses

Subject to the usage restrictions specified below, the Authorized Users are entitled to exercise the following rights: access, search, view, retrieve, and display of the Licensed Materials.

In addition, Authorized Users may make separate printouts or electronic copies of individual articles that do not constitute more than a minor part of a journal.

The commercial supply of copies of individual articles is principally not permitted. The Subscriber is, however, authorized to fulfil occasional requests from another institution within the same country of the Subscriber for single paper copies of an electronic original of an individual document wherever this is solely for Authorized Users of the institution in question for the purpose of research or private study.

This authorization explicitly does not apply for commercial purposes. Deviating special permits for such purposes can be negotiated with the Publisher by separate agreement.

Only Authorized Users may use a reasonable portion of the Licensed Materials for the preparation of printed or electronic course packages for use by Authorized Users at the Subscriber's institution, not, however, for commercial use or re-sale. Each such item shall carry an appropriate acknowledgment of the source.

2.2 The Subscriber acknowledges that the Licensed Materials, including any abstracts, are copy-right-protected and that the sole copyright to the Licensed Materials remains with the Publisher or the registered copyright holders. Alterations, revisions, translations, and adaptations of the publications that may infringe the copyright are expressly prohibited.

3.1 Prohibited uses

Neither the Subscriber nor his Authorized Users are permitted

- to publicly distribute the Licensed Materials or to disclose them to the public in any other way,
- to use the Licensed Materials or parts thereof for the purpose of monetary reward by means of sale, resale, loan, hire, or lease or any other form of commercial exploitation,
- to distribute any part of the Licensed Materials on any electronic network, including without limitation the internet and the World Wide Web, other than the Secure Network.

Every form of use of the Licensed Material beyond the authorized scope of use requires the prior written approval and extension of use by Franz Steiner Verlag.

4.1 Subscriber's undertakings

Institutional subscribers shall

- use reasonable endeavours to ensure that solely Authorized Users are granted access to the License Materials;
- use reasonable endeavours to notify their Authorized Users of the terms and conditions of this License Agreement and to take appropriate steps to protect the Licensed Materials from unauthorized use and other breaches of this License Agreement. This applies in particular for the issue of password and other access information solely to Authorized Users and pledging the Authorized Users not to divulge their passwords or other access information to third parties;
- use reasonable endeavours to monitor the compliance with these terms and conditions and, immediately on becoming aware of any unauthorized use or other breach, to inform the Publisher and take all reasonable and appropriate measures to prevent any further such misuse;
- upon the conclusion of this License Agreement immediately provide the Publisher with all necessary information to enable the Publisher to provide access to the Licensed Materials. In the event of any major alterations of these access conditions, these must also be reported immediately to the Publisher to ensure further access.
- The subscription fee must be paid into the Publisher's account within thirty days of receipt of the invoice.

4.2 Publisher's undertakings

The Publisher shall

- use all reasonable endeavours to make the Licensed Materials available to the Subscriber and to Authorized Users at all times and on a twenty-four hour basis, save for routine maintenance, and to restore access to the Licensed Materials as soon as possible in the event of an interruption or suspension of the service.

4.3 Under present policy, the Subscriber is also given access to issues published prior to the subscription period and available online at Ingenta. Such access is given on an ex gratia basis and no right is hereby created for the Subscriber to use or access any volumes and issues of the Licensed Materials other than that for which an institutional print subscription has been purchased.

4.4 The Publisher reserves the right at any time to withdraw from the Licensed Materials any item or part of an item for which it no longer retains the right to publish or make it available to third parties, or which it has reasonable grounds to believe infringes copyright or is defamatory, obscene, unlawful or otherwise objectionable.

4.5 The online access service offered by the Publisher is based on the currently valid technical, legal, and economic outline conditions for the data networks used. The place of data transfer is the interface between the Publisher's or third party's server and the internet or other data networks. The Publisher's responsibility for data transfer ends at that point. The use of the Licensed Materials is at the User's own risk. Access to the online version(s) of the Licensed Materials might be interrupted and may not be error-free. The Publisher does not assume any guarantee for the completeness and correctness of the electronic data. In the event of any inaccuracy or any discrepancy between the print and online versions, the print version shall be the official version of record. The Publisher does not assume any responsibility or liability for links to websites of third parties that may be included in the Licensed Materials, neither for their technical accessibility and 24/7 availability nor for their technical quality and quality of contents. The sole responsibility for such websites lies solely in the responsibility of the third party. The Publisher retains the right to deactivate or delete such links.

5. Substantive deficiencies

Any substantive deficiencies of the Licensed Materials shall be remedied upon their report by Franz Steiner Verlag in the context of the updating procedures regularly performed by the Publisher. Liability without fault is excluded.

The Publisher assumes no liability for damages, consequential or otherwise, arising from any temporary unavailability of the Licensed Materials.

The liability for the violation of major contractual obligations shall be limited to the compensation for damages that are contractually typical and could reasonably have been foreseen, except in cases of wilful intent and gross negligence.

The Licensed Materials are provided "as is".

6. Term, end of use, access after end

These Terms and Conditions of Use shall end

- upon the expiry of the paid subscription period for the print version and on default of payment;
- in the event of the Subscriber's serious breach of any of the terms and conditions;
- in the event of the material and/or persistent breach of any terms and conditions by Franz Steiner Verlag and its failure to remedy the breach within a reasonable period after written notification;
- in the event that either of the Parties becomes insolvent or subject to similar external administration.

With the termination of these Terms and Conditions of Use all rights and obligations shall end; in particular the Subscriber shall no longer be authorized to distribute or otherwise provide any Licensed Materials to Authorized Users.

The right of access to the online archive shall also end upon termination. This applies also and in particular to the contents that have been published and subscribed to during the term of these Terms and Conditions of Use.

7. Alterations of the Terms and Conditions of Use

These Terms and Conditions of Use may, for example, be adapted to changes in the basic legal regulations or to changes in the content-related scope of services offered, which is why it is recommended that you regularly read and check these Terms and Conditions of Use. In the event of any changes in these Terms and Conditions of Use, we shall post a corresponding note on this site. In the event that you do not agree with the amended version, you must notify us within a period of 14 days of the posting of the amended version. 8. Final provisions

In the event that either of the Parties is not able to fulfil his contractual obligations for reasons beyond its control, e.g. force majeure, this shall not constitute a breach of the License Agreement.

9. Applicable law and jurisdiction

The Parties to the License Agreement agree to the applicability of the German legal system. The place of performance shall be Stuttgart, Germany. The place of jurisdiction for transactions with business persons, with corporate bodies under public law, and with separate estates under public law shall also be Stuttgart, Germany.

10. Severability

In the event that individual provisions of these Terms and Conditions of Use are or become wholly or partly invalid or impracticable, this shall have no effect on the validity of the remaining provisions.
